RESEARCH STATEMENT

I have developed a strong research interest in the central role of culture, broadly defined, in understanding a wide array of psychological processes experienced by members of marginalized and underprivileged populations. For example, my studies examined cultural issues related to the process of loss and mourning in immigration, refugee trauma, Egyptian women empowerment, sexism, non-western rearing practices, political marginalization, and internalized sexual stigma. More recently, I examined issues related to cultural influences on psychotherapy and the integration of spirituality and traditional healing methods into clinical work. With respect to interdisciplinary applied research, I collaborated on a project that examined entrepreneur experiences by focusing on the cultural implications of these experiences.
